Project Title: Purisima Creek Redwoods Bicycle Parking Amenities Installation

Project Location: Purisima Creek Redwoods Open Space Preserve

City: Unincorporated San Mateo County

County: San Mateo County

Description of Project: The Midpeninsula Regional Open Space District proposes the installation of bicycle parking amenities at Purisima Creek Redwoods Open Space Preserve, including bike racks and a bike repair station. The bike racks are proposed to be installed near existing restrooms along Purisima Creek Trail at the Purisima Creek Road Parking Area (Location PC05) and Redwood Roadside Parking Area (Location PC03) (Attachment 1: Amenity Layouts). One corral style staple bike rack accommodating ten bicycles, a bike repair station, boot brush, bike brush, and incidental signage are proposed to be installed in a previously disturbed area near the restroom at Location PC05. Signage will encourage use of bike and boot brushes, aiming to reduce spread of pathogens. The bike rack, bike repair station, bike brush, and boot brush will be installed on concrete base. The incidental signage will be attached to an existing railing at the restroom. Proposed improvements at Location PC03 include two staple-style racks accommodating four bicycles. Minor vegetation clearing would be required to accommodate the bike racks at this location. Amenity locations were selected to be proximate to existing visitor-supporting infrastructure, and minimize impacts to operations and the natural environment. The endangered, Marbled Murrelet, is known to be present at the preserve during nesting season, and the amenities are proposed to be installed after nesting season concludes on September 15, 2025.

Exempt Status: In accordance with the State CEQA Guidelines, the proposed project is categorically exempt from CEQA under the following sections:

Sections 15303 – New Construction or Conversion of Small Structures: Class 3 consists of construction and location of limited numbers of new, small facilities or structures; installation of small new equipment and facilities in small structures; and the conversion of existing small structures from one use to another where only minor modifications are made in the exterior of the structure. The project proposes the installation of several small structures, including three bike parking structures, bike repair station, boot brush, bike brush, and incidental signage.

Sections 15304 – Minor Alterations to Land: Class 4 consists of minor public or private alterations in the condition of land, water, and/or vegetation which do not involve removal of healthy, mature, scenic trees except for forestry or agricultural purposes. The project proposes minor clearing of vegetation and trenching at Location PC03 to install bicycle racks with concrete base. This location is flat, which minimizes any grading or impact to lower-laying areas.

Amenities at Location PC05 would require minor trenching for installation of the concrete base. No trees would be removed and surfaces would be restored to approximate original grade.

Sections 15311 – Accessory Structures: Class 11 consists of construction, or placement of minor structures accessory to (appurtenant to) existing commercial, industrial, or institutional facilities, including but not limited to on-premise signs. The project proposes adding two signs and other minor accessory structures, such as bike racks, bike repair station, bike brush, and boot brush, which are accessory to the existing open space facilities and use of the site.

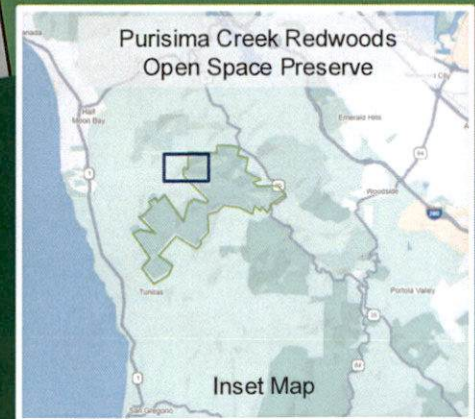

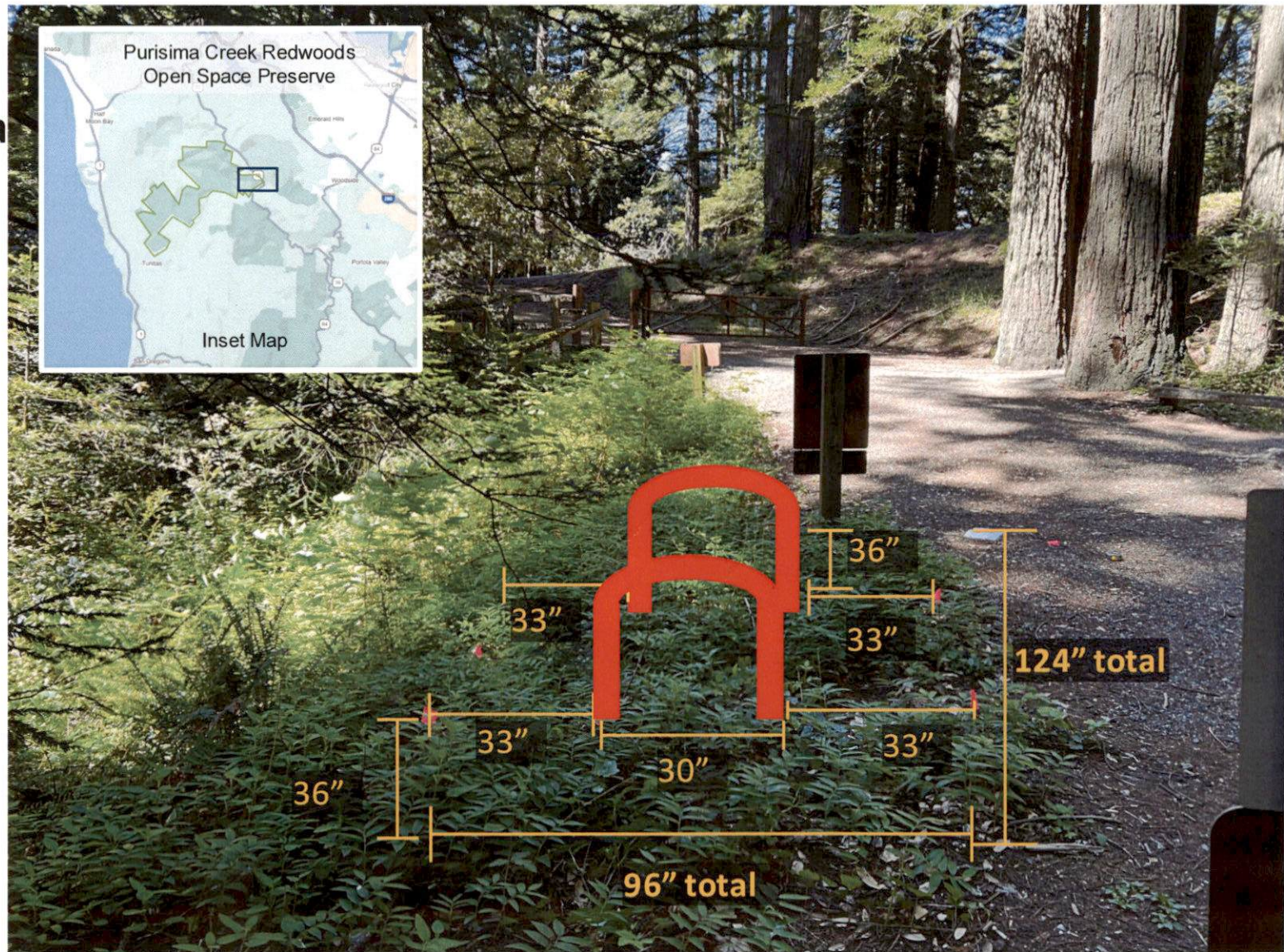

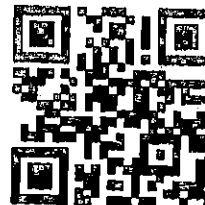
