0	March 2, 2010	Election Day - Mail ballots must be returned to county elections official no later than 8 p.m. in order to be counted. <i>EC §§1000 3020, 4103</i>
28	March 30, 2010	Last day for County to certify election results to district. <i>EC §15372</i>
