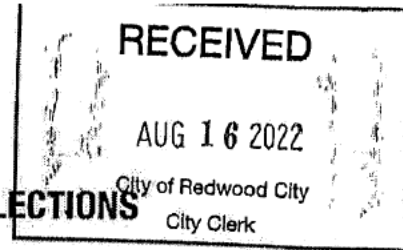

**Official Argument in Favor of Measure \_\_ (Mayoral Term Change)**  
**190 Words**

Voting Yes on \_\_ makes a simple, common-sense change to how long Councilmembers may serve as Mayor of Redwood City.

Currently, the position of Mayor rotates among Councilmembers every two years. With a seven-member City Council, each potentially serving four-year terms, some members may never have the opportunity to serve as Mayor. Also, some neighborhoods in Redwood City may never have the opportunity to be represented by the Mayor. Redwood City is the only city in San Mateo County that rotates mayor every two years.

Voting Yes on \_\_ reduces the term of Mayor of Redwood City to one year so that more Councilmembers have the opportunity to serve as Mayor. Measure \_\_ also ensures that more Council Districts throughout Redwood City benefit from having the Mayor as their representative on City Council.

Consider these facts:

Measure \_\_ does not increase taxes or the cost of running Redwood City Government

Measure \_\_ is designed to increase participation and representation in local government

Measure \_\_ is unanimously supported by the current Redwood City Mayor and City Council

Measure \_\_ approves a minor technical change in the rotation of Redwood City's Mayor and Councilmember positions to promote good government. Please join us in voting Yes.
