11 Basic necessities, like groceries and prescription medication, will not be taxed.

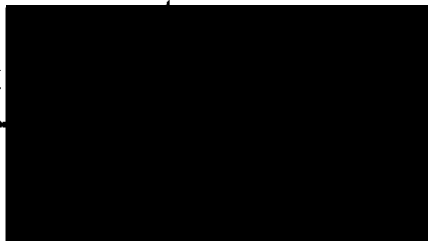
14 Visitors to Half Moon Bay will pay their fair share, so residents will not shoulder the
