TO THE CHIEF ELECTIONS OFFICER & ASSESSOR-COUNTY CLERK-RECORDER

WHEREAS, the California State Board of Education on March 12, 2015, upheld the action of the San Mateo County Committee on School District Organization after its consideration of the following:

Appeal of a decision by the San Mateo County Committee on School District Organization to Approve a Petition to Transfer Territory from the South San Francisco Unified School District to the San Bruno Park Elementary School District and the San Mateo Union High School District; and

WHEREAS, the petition to transfer said territory (hereinafter referred to as the "Merimont territory"), which consists of 70 residences located between 201-371 Merimont Circle; 101-107 Alden Court; and 200-215 Marbella Lane, San Bruno, CA 94066, is now approved; and

WHEREAS, the State Board of Education established the election area for the election on this issue as limited to persons of legal voting age residing in the Merimont territory; and

WHEREAS, on March 18, 2015, the San Mateo County Superintendent of Schools received notice of this action by the State Board of Education; and


WHEREAS, the California Education Code Section 35756 requires the County Superintendent of Schools to call an election on this issue within thirty-five (35) days of receipt of such notification;

NOW, THEREFORE, BE IT RESOLVED that this Resolution shall stand as the order to the San Mateo County Registrar of Voters to call an election on August 25, 2015, on the issue of whether the Merimont territory shall be transferred from the South San Francisco Unified School District to the San Bruno Elementary School District and the San Mateo Union High School District. The authority for the specifications of this election order is contained in Sections 35710 and 35710.51 of the California Education Code and Section 4000, et seq., of the California Elections Code; and

NOW, THEREFORE, BE IT FURTHER RESOLVED that the election be held in the area stipulated by the State Board of Education, consisting of 70 residences located between 201-371 Merimont Circle; 101-107 Alden Court; and 200-215 Marbella Lane, San Bruno, CA 94066, that comprise the Merimont territory; and

NOW, THEREFORE, BE IT FURTHER RESOLVED that, owing to the small number of voters in the Merimont territory, this election be conducted by mail and that the ballots be counted by hand.

Transfer of Territory from South San Francisco Unified School District  
to San Bruno Park School District and San Mateo Union High School District

Shall the Merimont territory consisting of seventy (70) parcels located along Merimont Circle, Marbella Lane, and Alden Court in San Bruno, California, be transferred from the South San Francisco Unified School District to the San Bruno Park School District and San Mateo Union High School District, such that by operation of law, persons residing within that territory would become residents of the San Bruno Park School District and San Mateo Union High School District, and be subject to those districts' parcel taxes, effective July 1, 2016? (61 words)

Transfer of Territory from South San Francisco Unified School District  
to San Bruno Park School District and San Mateo Union High School District

This ballot measure proposes to reorganize the South San Francisco Unified School District, San Bruno Park School District, and San Mateo Union High School District by changing the boundaries of the three school districts so that the real property along Merimont Circle, Marbella Lane, and Alden Court and described on the map entitled "Merimont Subdivision" dated June 2007 and recorded in book 135 of Maps, page 61, in San Mateo County Records, comprising and located at the addresses commonly known as 301 through 371 Merimont Circle, 101 through 107 Alden Court, and 200 through 215 Marbella Lane in San Bruno, County of San Mateo, California ("the territory"), which is currently located within the South San Francisco Unified School District, will be located within the San Bruno Park School District and San Mateo Union High School District beginning July 1, 2016. By operation of law, the proposed measure would make residents of the territory residents of the San Bruno Park School District and San Mateo Union High School District, with all the rights and responsibilities of other residents of the school district on the effective date. Owners of parcels within the territory would be subject to all taxes and other obligations of other parcels within the San Bruno Park School District and San Mateo Union High School District, in whatever manner may be defined by the governing laws of those school districts.
