That funding renovated/upgraded science and computer labs, libraries, classrooms, just 11  
to name a few – but there is still more work to be done, especially in our elementary 17

**FACT:** Measure H requires a clear system of accountability, including a project list 12  
detailing exactly how the funds will be used, a Citizens' Oversight Committee, and 13  
independent audits to ensure funds are spent properly. No bond monies will be used to 15  
pay administrator salaries/pensions. 4
