

RESOLUTION TO DECLARE AN EXEMPTION UNDER
THE CALIFORNIA ENVIRONMENTAL QUALITY ACT FOR
CAÑADA COLLEGE CHILD DEVELOPMENT CENTER

WHEREAS, the San Mateo County Community College District is the Lead Agency for the Cañada College Child Development Center,

WHEREAS, the Governing Board of the San Mateo County Community College District has determined that the above project is exempt from the California Environmental Quality Act (CEQA) under categorical exemptions set forth in CEQA Guidelines §15301 Existing Facilities, §15302 (replacement or Reconstruction), §15314 Minor Additions to Schools; and

WHEREAS, the Governing Board of the San Mateo County Community College District has reviewed and considered other school sites within its jurisdiction and determined that the construction site at Cañada College is the appropriate location for the project listed above; and

WHEREAS, the project will provide instructional and student services facilities for the students and community of the District; and

WHEREAS, the project will provide facilities for educational purposes that meet State standards and requirements; and

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Trustees of the San Mateo County Community College District that the Cañada College Child Development Center project is declared exempt under the provisions of the California Environmental Quality Act.
