**Description of Nature, Purpose, and Beneficiaries of Project:** The San Carlos School District ("District") is undergoing a District-Wide HVAC Upgrade Project ("Project") at its Mariposa Elementary School, located at 750 Dartmouth Ave., San Carlos, CA 94070 (APN: 049-162-230) ("Site"). The Project involves modernizing the District's existing HVAC systems at the Site by removing the District's existing HVAC systems and replacing them with newer and upgraded HVAC systems. Related site work and ancillary improvements are also part of the Project scope. This Project will generally benefit District students, staff, and the local community by improving the air conditioning capabilities of the Site. The work is anticipated to commence in Summer of 2025. The Site will have substantially the same purpose and capacity upon the completion of the Project.
