Description of Project The Ohlone-Portol'a Heritage Trail Historical Monument Project at Site 22 Cowell Purisima includes the installation of two interpretive sign panels and one State Historical Bronze Marker on a new decomposed granite pad at the existing Cowell-Purisima trailhead. One bike rack and bike station and associated concrete pad will be relocated to the west of the existing restroom, all other infrastructure and site features are to remain. The State Historical Broze Marker will be mounted on an approximately 42"x42" Serpentine or Granite Boulder and the Sign Panels will each be 36"x24" and mounted on two 3"x3" Steel Posts placed on a new 160 SF Decomposed Granite Pad. One Panel will focus on Ohlone village of Ssalime, a village of the Cotegen Tribe, and the other will provide a narrative of the Expedition Diaries specific to this site.

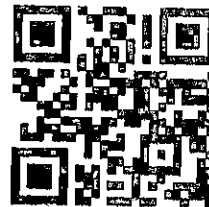
