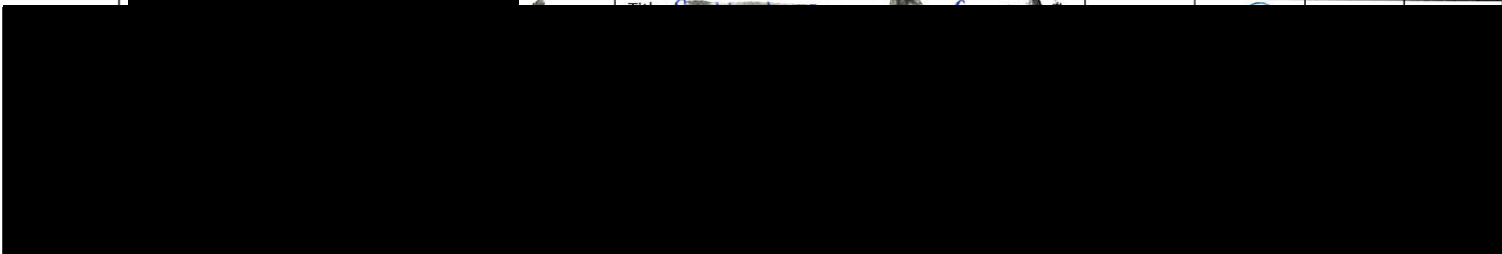

Rebuttal to the Argument Against Measure I

The authors of the argument against Measure I are simply not qualified to address the issues 15 facing our City. They do not live in Burlingame and have opposed virtually every local funding 16 measure in San Mateo County over the last decade. 7

As business leaders, public safety experts and longtime Burlingame residents, we know that 13 Measure I is the smart choice for a stronger, safer Burlingame. 10

Measure I is the fiscally responsible solution to fix our roads. Rather than waiting for costs to 16 escalate as our roads deteriorate further, we need Measure I now to maintain our city streets 15 and sidewalks, and repair potholes. 5

Strict accountability provisions ensure that the state and federal governments can't touch 12 Measure I. Every penny of Measure I must support essential city services like neighborhood 12 police patrols, pothole repair and parks and recreation programs for youth, teens and seniors. 14 Independent citizens' oversight, mandatory financial audits and yearly reports to the 11 community will ensure Measure I supports critical Burlingame services, and never city 11 administrator salaries. 2

Groceries, medicine and other essentials are exempt from Measure I. Additionally, Measure I 11 makes certain that Burlingame's visitors pay their fair share for their impact on our roads. 15

Safe neighborhoods, strong schools and beautiful parks are integral to our strong quality of 14 life here in Burlingame. Voting Yes on Measure I will enhance neighborhood police patrols, 13 improve safe routes to school and maintain city streets and parks, keeping Burlingame safe and 15 desirable. 1

Let's not be misled by two out-of-town, out-of-touch voices. Please join us — vote Yes on 19 Measure I. 1
